- 1) All applications are subject to the approval of the clergy team of the Great Neck Episcopal Ministry (GEM).
- 2) A deposit of \$ 100.00 must be made at the time of application.
- 3) Set up may be done prior to the event as long as scheduled in advance with the church. Use must end at 10:00 pm unless otherwise agreed upon.
- 4) Buildings must be restored to original condition. Please remove and clean any decorations or set ups. Any extra costs incurred in returning the facilities to a condition satisfactory to church must be paid.
- 5) Use of kitchen is limited to storage and preparation. No cooking is allowed unless otherwise agreed upon.
- 6) Absolutely no smoking indoors.
- 7) No alcoholic beverages served in any facilities without the prior written approval of the clergy.
- 8) All trash must be picked up and left in garbage bags securely closed and left in the kitchen.
